## **Implied Warranties Only Buyers Guide Form for New York**

If a driver is buying an older vehicle that was manufactured before 1972 (or other non-titled vehicles), the seller can fill out a Certificate/Affidavit of Sale or Transfer (Form MV-51). The seller can also use a bill of sale and a Certification of NYS Registration for Transfer of Non-Titled Vehicle (Form MV-353).

NY Vehicle Registration Paperwork. Once you've received the appropriate paperwork from the seller, bring all documents to your local DMV office and submit them, along with the following: A completed: Vehicle Registration Application (Form MV-82).; Statement of Transaction (Form DTF-802).. This form is required for the DMV to calculate and collect sales tax on the vehicle.
